

FACTS**WHAT DOES TEWKSBURY FEDERAL CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?**

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.																						
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> • Social Security number • Payment history and Account Balances • Credit history and Credit Score 																						
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons Tewksbury Federal Credit Union chooses to share; and whether you can limit this sharing.

What we do																							
How does TFCU protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We also maintain other physical, electronic, and procedural safeguards to protect your information and we limit access to information to those employees for whom access is appropriate.

How does TFCU collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> • Open an account • Apply for a loan • Make deposits or withdrawals from your account <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies</p>						
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> • Sharing for affiliates' everyday business purposes – information about your credit worthiness • Affiliates from using your information to market to you • Sharing nonaffiliates to market to you 						
What happens when I limit sharing for an account, I hold jointly with someone else?	Your choices will apply to everyone on your account.						
Definitions							
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.						
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.						
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
